Membership of the Bell Tower Community Association (BTCA) is available to individuals and organisations living, working or situated (in the case of organisations and businesses) within the boundary of the Community Association area.

The membership year begins in March each year and membership allows you to:

- ❖ Vote in Annual General and other meetings of the Association
- ❖ Become a member of the Management Committee
- ❖ Nominate someone else to be a member of the Management Committee
- ❖ Participate in BTCA's Local Trader Discount Scheme*

There are three types of membership:

Adult: for anyone living within the BTCA area aged 18 years or over. Fee £1.00 per person per year (or part thereof)

Junior: for anyone living within the BTCA area aged 17 years or under. Fee £0.50 per person per year (or part thereof)

Corporate: for businesses and organisations located within the BTCA area. Fee £1.00 per organisation per year (or part thereof)

* *The Local Trader Discount Scheme is only available to individual members*

Please note that:

- ❖ Membership Cards are not transferable
- ❖ Membership Cards remain the property of BTCA at all times
